Проблемам внутренней эволюции Европейского союза (развитие концептуальных моделей интеграции, институтов ЕС, европейского права, систем принятия решений, отдельных политик) посвящено значительное количество исследований академического и экспертного характера, однако, в большинстве таких работ рассматриваются внутренние аспекты функционирования Евросоюза. Меньшее количество исследований посвящено взаимосвязи внутренней эволюции ЕС и его внешнеполитической деятельности, и очень небольшое количество работ фокусируется на изучении комплексных взаимосвязей внутренних изменений в Евросоюзе и его отношений с отдельными странами, включая Россию. В то же время существует большое количество работ посвященных эволюции акторности Европейского союза на международной арене и его внешнеполитических инструментов, а также развитию внешней политики Евросоюза.<sup>1</sup>

Среди исследований, в которых затрагивается взаимосвязь между эволюцией Европейского союза и развитием отношений между ним и Россией можно выделить ряд работ посвященных анализу взаимодействий Евросоюза и России в отдельных секторах (отношения в торгово-экономической сфере, и особенно в области энергетики<sup>2</sup>; «общее

пространство» свободы, безопасности и правосудия, в особенности, вопросы миграции;<sup>3</sup> проблемы политических институтов и человеческого измерения<sup>4</sup>) или в смежных регионах (прежде всего Балтийский регион и регион «общего соседства»<sup>5</sup>). Также некоторые работы рассматривают формирование отношения к «российской повестке» отдельными институтами Европейского союза.<sup>6</sup> В значительной части этих исследований рассматривается вопрос о распространении на Россию норм, правил и стандартов ЕС в процессе сотрудничества с ней. Также в этом контексте следует обратить внимание на

ряд работ, исследующих ключевые аспекты (двусторонние документы, инициативы) и тенденции отношений Евросоюза и России.<sup>7</sup>

Влиянию отдельных стран-участниц Евросоюза на формирование отношений между ЕС и Россией<sup>8</sup> посвящено большее количество исследований по сравнению с количеством работ, в которых анализируется влияние институтов Европейского союза на формирование и реализацию его политики по отношению к России. В этом контексте значительное количество исследований фокусируется на изучении двусторонних отношений между Россией и ведущими странами-участницами ЕС (прежде всего, Германия,<sup>9</sup> а также Великобритания<sup>10</sup>) и их влияния как на отношения между Россией и

Европейским союзом, в целом, так и на формирование институтами Евросоюза политики по отношению к России.

Также можно выделить ряд работ посвященных отношениям между Россией и странами Центральной и Восточной Европы (прежде всего, страны «Вишеградской группы» и, в особенности, Польша).<sup>11</sup> В некоторых из этих исследований ставится вопрос о необходимости большей согласованности и интегрированности политик стран Центральной и Восточной Европы по отношению к России в контексте их членства в Евросоюзе и евроатлантических институтах.

Некоторые исследования посвящены отношениям между Россией и странами балтийского и северо-европейского регионов<sup>12</sup> (в особенности, страны Балтии)<sup>13</sup> и их влиянию на отношения между Европейским союзом и Россией, в целом.

В заключение следует отметить, что упомянутые в обзоре работы, безусловно, не исчерпывают исследовательскую повестку по тематике отношений между Россией и Европейским союзом в контексте его внутренней эволюции, однако, они дают представление об основных направлениях и характере зарубежных исследований в этой области.
