**Общая внешняя политика и политика безопасности ЕС и отношения
с Российской Федерацией в зарубежных исследованиях**

Несмотря на то, что Общая внешняя политика и политика безопасности (ОВПБ) была сформирована только в начале 90-х гг. и до сих пор остается не слишком активным направлением деятельности ЕС, не выдерживая конкуренцию с внешней политикой отдельных государств-членов, зарубежные исследователи довольно активно изучают данную политику Евросоюза, рассматривая в том числе и ее влияние на развитие отношений с третьими странами, в том числе с Российской Федерацией.

Обзор зарубежных исследований, посвященных проблемам сотрудничества между Россией и Европейским союзом в сфере безопасности базируется на публикациях в научных журналах (например, European Security, Cooperation and Conflict, Journal of Contemporary European Studies, European Foreign Affairs Review, Europe-Asia Studies, The International Spectator), публикациях исследовательских центров и институтов (например, Центра исследований европейской политики (CEPS) и Финского института международных отношений (ФИА)), материалов научных конференций и др.

Можно выделить несколько ключевых тем, которые рассматриваются в зарубежных исследованиях. Прежде всего, это публикации, посвященные развитию внешнеполитической деятельности Евросоюза, формированию ОВПБ, усилиям по гармонизации внешнеполитической деятельности различных государств-членов, которые затрагивают политику Евросоюза в отношении России. К таким публикациям можно отнести работы К. Арчер, К. Барыш, Р. Бенгтссона, С. Блокманса, М. Вебера, Д. Дж. Галбрита, Д. Гроса, С. Де Шпигелера, Л. Делкур, А. Ласас, Р. Линтонена, С. Медведева, Л.

Симао, А. Тойвонена, Э. Тулметс, А. Шмидт-Фелцман, Х. Хауккала и Р. Янгса¹. Некоторые исследователи публикуют материалы, посвященные особенностям Европейского союза как международного актора, но при этом затрагиваются и сюжеты, связанные с влиянием Евросоюза на Россию. Среди таких авторов можно отметить М. Вебера, А. Макарычева, Н. Точки, Д. Хамильтона, Ф. Хесбура².

Во многих зарубежных публикациях рассматривается развитие политического сотрудничества между Евросоюзом и Россией, подобная проблематика освещается в работах Н. Арбатовой, С. Блокманса, Т. Бордачева, М. Валя, Д. Гроса, С. Караганова, А. Макарычева, Ф. Тассинари, С. Фернандес, Х. Хауккала и М. Эмерсона³. Некоторые

Марша, Э. Норина, Л. Симао, М.А. Смита, Г. Тимминса, Т. Форсберга, М.Р. Фрер, Р. Эллисона, М. Эмерсона⁶. Конкретные примеры сотрудничества в области безопасности рассматриваются в публикациях Д. Аверре, К. Браунинга, Т. Долидзе, Р. Линтонена, О. Реута, Ф. Тассинари⁷.

Следует также отметить, что вопросы политического сотрудничества и проблемы безопасности в отношениях ЕС и России затрагиваются в зарубежных публикациях, исследующих политику ЕС в отношении восточных соседей и отношения Евросоюза с различными пост-советскими государствами. Таких публикаций чрезвычайно много, но в качестве примеров можно вспомнить работы Д. Аверре, В. Амаро Диаса, К. Браунинга, Л.

Безусловно, вопросы взаимодействия России и Евросоюза в области безопасности представляются актуальным и важным направлением зарубежных научных исследований. Список публикаций, проанализированных в данном обзоре, не является исчерпывающим, но он позволяет сделать выводы о ключевых проблемах, затрагиваемых в зарубежных научных публикациях.
